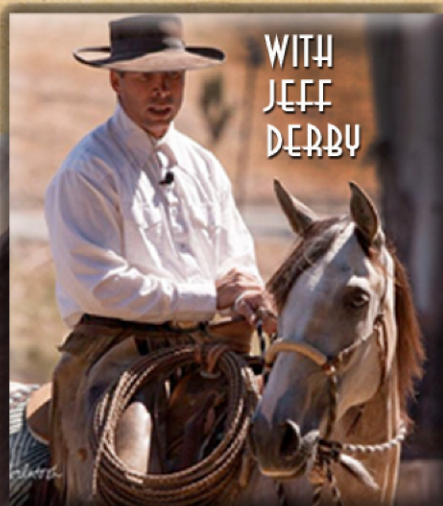

BRUCE SANDIFER CLASSICAL CALIFORNIO HORSEMANSHIP VOLUNTARY RELEASE
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

I, _____, Hereby acknowledge, that I have voluntarily applied to participate in instruction and training in the starting, training, selection, care, handling,, and riding of horses with BRUCE SANDIFER CLASSICAL CALIFORNIO HORSEMANSHIP, Californio Bridlehorse Association, such instruction to take place on the premises of _____.

I am aware that activities involving horses can be inherently dangerous and hazardous, and I am voluntarily participating in these activities with knowledge of the danger involved and hereby agree to accept any and all risks of injury or death.

In consideration for being permitted to participate in said instruction and training:

1. I hereby release, waive, discharge, and covenant not to sue, BRUCE AND UTE SANDIFER, individually and doing business and BRUCE SANDIFER CLASSICAL CALIFORNIO HORSEMANSHIP and SANDIFER BRIDLE HORSE COMPANY, Californio Bridlehorse Association, each and every agent, employee, or rider, thereof, and the Sponsor or Sponsors named above, all for the purposes herein referred to as 'Releasees' from all liability to myself, my legal representative, distributees, guardians, assigns, heirs, and next of kin, all for the purposes herein referred to as 'Releasors' for injury, death or damage resulting from my participation in said instruction and training as a result of negligence of releasees, or any employee, servant, agent or contractor of Releasees. I further release and discharge releasees from all liability to releasors for injury, death, or damage resulting from my participation in said instruction and training as a result of the negligence of any other party or parties in attendance. In addition, I hereby release and discharge releasees from all actions, claims or demands releasors now have or may hereafter have for injury, death or damage resulting from my participation in such activities.
2. I hereby agree to indemnify and save and hold harmless releasees, and each of them, from any loss, liability, damage or cost they, or any of them, may incur due to my participation in said instruction and training.
3. I hereby assume fully responsibility for and risk of bodily injury, death or property damage due to the negligence of releasees, or any of them, or of any employee, servant, agent or contractor of releasees resulting from my participation in said instruction or training.
4. I expressly acknowledge that activities involving horses involve inherent risks which mean that there are dangers or conditions which are an integral part of horses activities and include, among other things, the propensity of a horse to behave in ways that may result in injury, harm or death to person on or about them: and the unpredictability of a horse's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals.

I have carefully read this release and waiver of liability and indemnity agreement and fully understand its contents. I am aware that this is a RELEASE of liability and a contract between myself, BRUCE AND UTE SANDIFER, Bruce Sandifer Classical Californio Horsemanship and Californio Bridlehorse Association, I sign it of my own free will and further agree that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

I have read this document. I understand it is a release of all claims. I understand that I assume all risk inherent in activities with horses. I voluntarily sign my name evidencing acceptance of the above provisions.

PARTICIPANT AGREEMENT, RELEASE, AND ACKNOWLEDGEMENT OF RISK

In consideration of the services of V6 Ranch, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "V6"), I hereby agree to release and discharge V6, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that horseback trail rides ("rides") entail known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to me, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing to essential qualities of the activity.

The risks include, without limitation: loss of control, falls, and collisions; unpredictable behavior by horses based upon instinct, fright, or lack of proper rider control; latent or apparent defects or conditions in equipment, animals, or property; acts of other participants in this activity, adverse weather conditions; contact with plants or animals; my own physical condition or my own acts or omissions; the condition of remote roads, trails, waterways, or terrain; first-aid, emergency treatment, or other services rendered; and consumption of food and drink.

V6 also permits non-equestrian activities, including hiking, water activities, sightseeing, and other recreational activities. These recreational activities present many of the same risks involved in rides and possibly additional risks. These risks include those presented by the condition of the property and the weather, the acts of other participants, and my own actions and physical condition.

V6 guides have difficult jobs to perform. Their goal is safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather, the elements, or the terrain. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

In addition to the risks inherent in horseback trail rides under normal circumstances, I acknowledge an additional risk of illness during the COVID-19 pandemic. I could contract COVID-19 or other diseases such as the flu that could result in a serious medical condition requiring medical treatment in a hospital or could possibly lead to death.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to defend, indemnify, and hold harmless V6 from any and all claims, demands, or causes of action in any way connected with my participation in this activity or my use of V6's equipment or facilities, including any such Claims alleging negligence of V6.
4. Should V6 be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating. In the alternative, I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition.
6. If I file a lawsuit against V6, I agree to do so in Monterey County Superior Court or, where permitted, in the United States District Court for the Northern District of California, and I further agree that the substantive law of California shall apply in that action without regard to the conflict of law rules of that state.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against V6 based on any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.

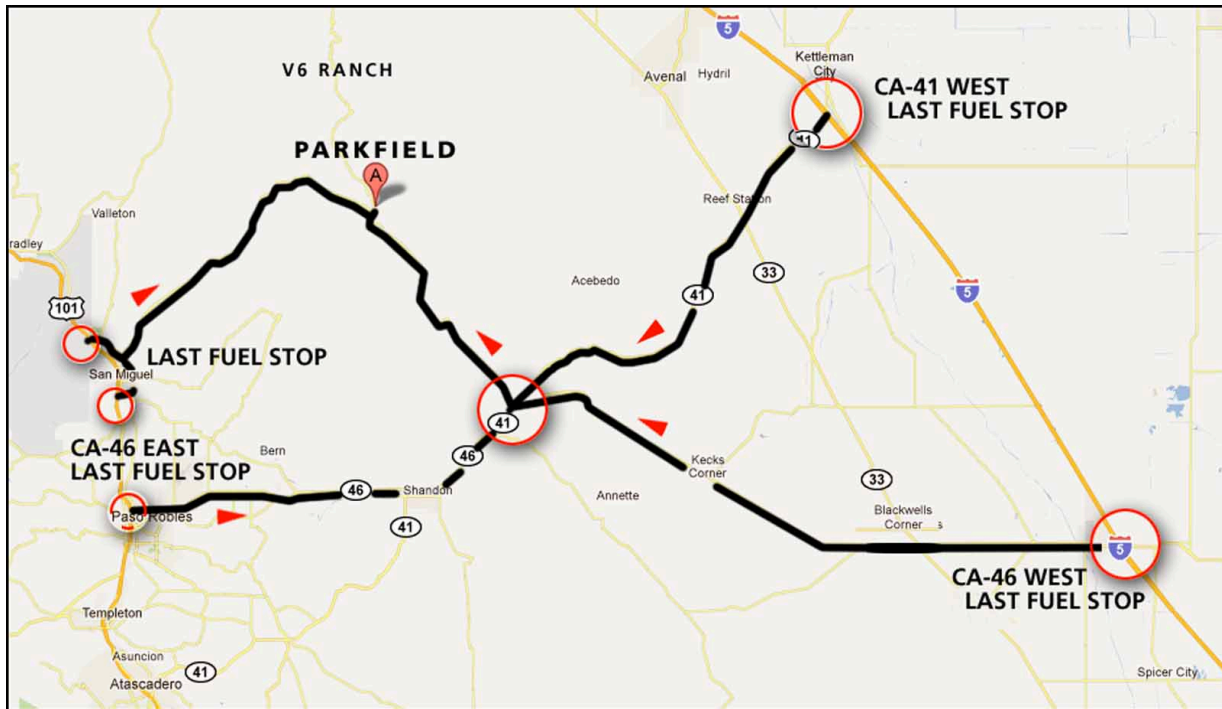
